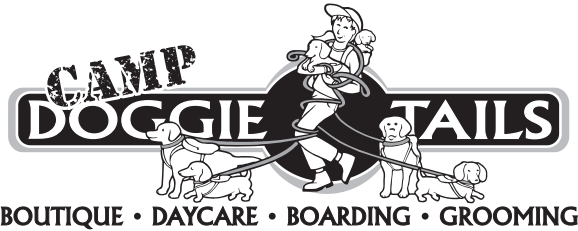

DAYCARE/BOARDING APPLICATION

DAYCARE/BOARDING RULES AND REGULATIONS

- 1. All dogs must be up-to-date on vaccinations.** Owners must submit written proof that dogs have received the required vaccinations within the specified time period recommended by a veterinarian. Camp Doggie Tails requires Bordetella boosters every six months, DHPP vaccinations every three years after initial one year booster, and Rabies vaccinations every three years after initial one year booster. All dogs must also provide proof of a negative fecal exam within the last month.
- 2. All dogs must be spayed or neutered at 6 months of age.**
- 3. Any dog with a communicable disease in the past month will require veterinarian documentation of good health before it is admitted.**
- 4. Dogs must have a current daycare/boarding application on file.** There is a \$10.00 initial daycare/boarding assessment fee, which is applied to the purchase of first monthly daycare package.
- 5. All dogs must display health and temperament characteristics that are conducive to a fun, safe daycare/boarding environment.** We reserve the right to refuse initial service or terminate service at anytime without prior notice and at our sole discretion.
- 6. Reservations are required.** Reservations will be dependent on space availability. Preference will be given to dogs with regular standing reservations.
- 7. Payment in full for all charges incurred on behalf of a dog are due upon pick-up from daycare or boarding.** A deposit or prepayment may be required for some services.
- 8. Daycare dogs must be picked up before closing.** Owners will be charged \$1.00 for every minute their dog remains after closing to a maximum of \$30.00 (per dog). If a dog remains thirty minutes or more past our daycare closing time, we reserve the right to board the dog at our Tigard location or transport the dog to another location for holding until the owner arrives for pick-up. An additional fee of \$35.00/dog will be charged for transport or for boarding.
- 9. In the event a dog requires emergency veterinary care while at Camp Doggie Tails, Inc., it will be handled as deemed best by our staff.** The dog owner agrees to assume full financial responsibility for any expenses involved.

CAMP DOGGIE TAILS DAYCARE/BOARDING AGREEMENT

I understand that there are dangers and risks (both apparent and unanticipated) inherent in my dogs participation in daycare and/or overnight boarding and I accept all such dangers and risks.

I understand that I am responsible for any injuries, damages or losses caused by my dog while my dog is attending daycare/boarding. I further understand that in welcoming and accepting my dog, Camp Doggie Tails has relied on my representation that my dog is in good health and has not harmed or shown aggression towards any person or other dog. I also represent that my dog has never been denied admission to or asked not to return to another daycare or boarding facility.

I hereby knowingly, intentionally and voluntarily waive, release, indemnify, and agree to hold harmless Camp Doggie Tails, Inc and all of it's employees, officers, directors, consultants, independent contractors, assigns and agents from any and all actions, suits, claims, damages, liability, and loss (including attorney fees and costs) that I may have arising out of or related to my dogs participation in daycare and overnight boarding. I further understand and agree that any problem that develops with my dog will be treated as deemed best by the staff of Camp Doggie Tails, Inc and I assume full financial responsibility for all expenses involved.
